If you are prohibited from using computers, we've included phone numbers and addresses where available. If you do not have a computer, public libraries in Oregon have computers connected to the web. Librarians will help you learn to use them if you ask. If you are in the Portland area, Free Geek (<http://www.freegeek.org/> (503)232-9350) is a non-profit that allows people to "adopt a computer" in exchange for 24 hours of service.
